THE GREAT PARKS OF HAMILTON CO.

- The Great Parks of Hamilton Co. is a nonprofit organization that oversees most of our local parks in all of Hamilton County.
- The organization was founded in 1930 as the Hamilton Co. Park District.
- Great Parks is a separate subdivision of the State of Ohio.
- The Great Parks of Hamilton Co. is operated by a board of commissioners. The board is made up of five individuals.
- In addition to the board of commissioners, the park also has an operating team that consists of a CEO, CFO, etc.
- All the Great Parks of Hamilton Co. are open dusk to dawn, 365 days a year.

COMPREHENSIVE MASTER PLAN

The Great Parks of Hamilton Co. completed a master plan in January of 2019. The purpose of this plan was to act as a guide document to all of the parks and set the vison for facilities, programming, and services over the next 10 years of operation.

The Master plan identified eight priorities for implementation:

- Build more trails
- Add programming and events for diverse audiences
- Provide access to conservation areas
- Establish a blueway system (special trails for people with interest in water sports)
- Focus on partnerships
- Build ecological resiliency and sustainability
- Expand access for all users
- Plan for the future of every park



MY EXPERIENCE

Over the course of the spring semester, I worked with Great Parks of Hamilton Co. doing various activities! I met many new people; some that work at the parks, students like me, and others that just frequently volunteer! The time I have spent with Great Parks has been amazing. The parks rely heavily on the help of volunteers to carry out the necessary functions at the parks. The process has been very humbling for me. Picking up litter has made me appreciate the work that goes into maintaining the parks (and taught me that people can be gross!) The volunteer events have all left me feeling tired and worn out. Lastly, I would also recommend creating some sort of signage at ALL parks. Some parks have great signage that give you directions to certain areas. Then, on the other hand, I've been to a few of their locations that don't have any signs at all.

Overall, I will encourage EVERYONE to give Great Parks of Hamilton Co. a try if they want to get involved in our community and volunteer. The work is rewarding, fun, and provides great exercise working outdoors!
